

## PUBLIC NOTICE

Be it ordained by the Selectboard of the Town of Chelsea, Vermont, as follows:

### **Amendment to the Road Name Ordinance of the Town of Chelsea, Vermont**

#### 1. General Provisions

1.11 This ordinance is enacted pursuant to 24 V.S.A. § 2291 (3) and (16), 4421, and 1971 and 19 V.S.A. § 304(17) . This amendment to the Road Name Ordinance of the Town of Chelsea, shall be adopted and take effect in accordance with the procedures and provisions set forth in 24 V.S.A. Chapter 59.

1.12 Each provision of this ordinance shall be deemed independent of all other provisions, and, if any such provision is declared invalid or unenforceable, all other such provisions shall remain valid and enforceable.

#### 2. Definitions of words and phrases - For purposes of this ordinance, the following words and phrases shall have the meaning set forth herein.

2.1 "Board" means the Selectboard of the Town of Chelsea, Vermont.

2.2 "Private Road" means a driveway or other way other than a road which is used to provide vehicular access to more than one primary building or lot.

2.3 "Road" means the entire width between boundary lines of any public street, highway, roadway, or other way or place of whatsoever nature when any part thereof is permanently or temporarily open to the use of the public for the purpose of vehicular traffic and shall include a way laid out under the authority of law.

2.4 "Town" means the Town of Chelsea, Vermont.

2.5 "Town Highway Map" means the map of the Town and or state highways provided by the Vermont Agency of Transportation from time to time pursuant to 19 V.S.A. § 305(e).

#### 3. Designation of Road Names - The official name of all roads of the Town as identified by Town highway map number are hereby amended to the name set forth next to the Town highway map number. The official number of said streets of the Town shall be the number for such streets as designated by the Town highway map. These road names are amended as follows:

TH #3 - From Route 110 straight through TH #73 (Taylor Valley) to the Vershire town line will be Jenkins Brook Road.

TH #42 - Off Brook Road by Fred Patterson's will be known as Carpenter Rd.

TH #76 - North Common.

Private road off TH #47A (Town Farm Road) leading to Ellen Hovde's will be called Huxley Lane.

This ordinance is adopted on April 4, 2000, and shall become effective in 60 days on June 3, 2000.

Pursuant to the provisions of 24 V.S.A. § 1973, the citizens of the Town of Chelsea have the right to petition for a vote on this Ordinance at the Selectboard Meeting on May 2, 2000 at 7:00 p.m. in the Town Office. If no petition is filed, this ordinance shall become effective 60 days after the date of its adoption.
